

# FEDERAL GREEN JOBS LEGISLATIVE CONFERENCE

Three Events - One Day! March 2, 2010

The Federal Green Jobs Legislative Conference will bring a panel of Department of Energy (DOE) and Department of Labor (DOL) officials and other key national and state green job policy makers to Hampton Roads to have them brief the region's business, labor, government and community leaders and citizens on recent and pending federal legislation directly impacting green economic growth, green workforce training and green job creation.
